In accordance with the standards of the European Bank for Reconstruction and Development (EBRD), we will make an analysis in respect of setting certain qualification criteria which tenderers will have to fulfill, and also consider and identify the level of tender conditions which will stimulate participation of companies at the tender. We want to achieve transparency and openness in this process with discussions and feedback from you, in order to make sure that certain criteria do not significantly limit or discriminate companies which are capable and qualified for participation. In this manner, not only we affirm the industry of overhaul services, but we also create assumptions for development of regional and international cooperation in this field.
